INFRASTRUCTURE & DEVELOPMENT

- 1. Department of Development, submitting a contract with The Cleveland Orchestra in the amount not-to-exceed \$225,000.00 for the Star-Spangled Celebration for the period 1/1/2002 12/31/2002.
- 2. County Engineer, recommending to accept various projects as complete and in accordance with plans and specifications:
 - a) 2001 Operations Resurfacing Program, Group A: Bennett Road from Edgerton Road to South Akins Road in the City of North Royalton and Trebisky Road from the Richmond Heights South Corporation Line to Highland Road in the City of Richmond Heights.
 - b) resurfacing and expansion joint replacement on Egbert Road Bridge No. 154 in the City of Bedford and Mill Street Bridge No. 16 in the City of Olmsted Falls.
 - c) improvement of Smith Road from Snow Road to Brookpark Road in the City of Brook Park.
- 3. County Engineer, recommending the appropriation of property rights in connection with the improvement of Sprague Road from Pearl Road to Webster Road in the Cities of Middleburg Heights and Strongsville:

County Engineer, recommending that public convenience and welfare requires the vacation of Avon Road, 50 feet from the Westlake West Corporation Line to 2,426.02 feet east of Bradley Road in the City of Westlake; requesting the Clerk of the Board to set the dates for the view and the public hearing.
- 5. County Engineer, submitting applications for allocation from County Motor Vehicle \$5.00 License Tax Funds:
 - a) in the amount of \$257,910.29 for the rehabilitation of Monticello Boulevard Bridge No. 199 over Euclid Creek in the City of South Euclid.
