MEMORANDUM

May 1, 2001 Agenda Actions

The regular meeting of the Board of Cuyahoga County Commissioners was called to order at 3:07 P.M. Commissioners Jane L. Campbell, Jimmy Dimora and Tim McCormack were in attendance.

The May 1st meeting resulted in the following actions:

- Items #1 – 5 were considered in order and adopted by unanimous vote.
- Item #6, which included a public hearing, was postponed to 3:30 P.M.
- Items #7 – 13 were considered in order and adopted by unanimous vote.
- Item #14 offered the following recommendations:

“Recommending to appoint David Deming and Darnell Brown to the Cuyahoga County Board of Mental Retardation and Developmental Disabilities, each to a term commencing 1/1/2001 – 1/1/2005, effective May 1, 2001.”

Both recommendations were adopted by unanimous vote.

- Items #15 – 17 were considered in order and adopted by unanimous vote.
- Item #18 was held at the request of the County Administrator.
- Items #19 – 25 were considered in order and adopted by unanimous vote.
- At this time, consideration returned to Item #6 and the public hearing was opened at 3:34 P.M. Bond counsel briefly spoke to the project after which Commissioner Dimora called for public comment and, hearing none, the public hearing was officially closed at 3:36 P.M. The item was adopted by unanimous vote.

- Consideration returned to the regular order of the agenda and Item #26 was adopted by unanimous vote.
- Consideration moved to Item #27 and the recommendation for RQ0369 was held at the request of the department. The recommendations for RQ0392 and RQ0642 were adopted by unanimous vote.
- Items #28 – 31 were considered in order and adopted by unanimous vote.
- Item #32a was held at the request of the department.
- Items #32b – 40 were considered in order and adopted by unanimous vote.
- At this time, Deputy County Administrator Bette Meyer presented the Welfare Reform Update. As part of the presentation, Interim Director Rick Werner provided highlights of the Cuyahoga Work & Training Progress Report through March 31, 2001.
- County Administrator Tom Hayes made a presentation to the Board summarizing the State Auditor's Performance Audit of the Cuyahoga County Juvenile Court.
- With no further business to be brought before the Board, the meeting was adjourned at 4:57 P.M.
