AGENDA ACTIONS

October 14, 2003

The regular meeting of the Board of Cuyahoga County Commissioners was called to order at 2:51 P.M. Commissioners Jimmy Dimora, Peter Lawson Jones and Tim McCormack were in attendance.

The October 14th meeting resulted in the following actions:

Two additional items, not on the printed agenda, were offered for consideration:

Department of Development, submitting an amendment to the FY2003 Action Plan with the U.S. Department of Housing and Urban Development to establish refinancing guidelines for the Cuyahoga Housing Consortium for the HOME Program.

Department of Development, submitting contracts with K&D Enterprises, Inc. for a forgivable loan in the amount not-to-exceed \$1,200,000.00 for the Water's Edge Apartments Project in connection with the Cuyahoga Housing Consortium for the HOME Program for the period 10/7/2003 – 6/30/2004:

- a) FY2000 in the amount not-to-exceed \$301,696.00.
- b) FY2001 in the amount not-to-exceed \$434,392.00.
- c) FY2002 in the amount not-to-exceed \$217,776.00.
- d) FY2003 in the amount not-to-exceed \$246,136.00.

Both items were considered and each were adopted by unanimous vote.
