AGENDA ACTIONS

June 19, 2008

The regular meeting of the Cuyahoga Board of County Commissioners was called to order at 10:23 a.m. Commissioners Jimmy Dimora and Peter Lawson Jones were in attendance. Commissioner Hagan was not in attendance.

The June 19th meeting resulted in the following actions:

INFRASTRUCTURE & DEVELOPMENT

 - c) interim resurfacing of Ridge Road from Interstate 480 to Memphis Avenue in the City of Brooklyn.
